STA Scholarship Overview

The Syracuse Teachers Association Scholarship is \$500.00 a semester; four-year award (\$4,000.00 total award) given to a senior in high school who plans to enter a profession requiring higher education at an accredited institute of learning.

The Richard A. Kassman Scholarship award winner, will receive a one-time payment of \$500.00 and will serve as an alternate for the STA Scholarship.

Eligibility will be limited to the children of Syracuse Teachers Association members.

- Only applications that are COMPLETE and ON TIME are considered.

Student must submit the following:

- Completed Scholarship Application
- Official school transcript
- Written references - from two adults, one of whom must be a faculty member (neither of whom can be a relative).
- Essay (see last page for details)

Selection Criteria

- Scholarship Committee members consider the potential, the recommendations, the activities, and the need of the applicants, as reflected in the application, transcripts, recommendations, and essay submitted.

- Awards will be presented to the scholarship winners at the June STA Rep Assembly.
